## Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement READ BEFORE SIGNING

IN CONSIDERATION of being permitted to compete or participate in any way in the Virginia City Grand Prix (hereinafter referred to as "EVENT") or being permitted to enter for any purpose any RESTRICTED AREA (defined as any area requiring special authorization, credentials or permission to enter or any area to which admission by the general public is restricted or prohibited including but not limited to the competition area and any hot pit area), THE UNDERSIGNED, for them self, if the age of majority, or the minor and their parent or guardian (hereinafter collectively referred to as "PARTICIPANT"), and for PARTICIPANT's personal representatives, heirs, and next of kin:

- Acknowledges, agrees, and represents that they have or will immediately upon entering any such RESTRICTED
  AREAS, and will continuously thereafter, inspect the RESTRICTED AREAS which they enter and they further agree
  and warrants that, if at any time, they are in or about RESTRICTED AREAS and they believe anything to be unsafe
  or unsatisfactory in any way, they will immediately advise the officials of such and will leave the RESTRICTED
  AREAS and/or refuse to participate further in EVENT. PARTICIPANT acknowledges they may not have the
  opportunity to inspect any RESTRICTED AREA prior to the event.
- 2. HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the Virginia City Motorcycle Club, including its officers, members and volunteers, government agencies, promoters, participants, racing associations, sanctioning or administrative organizations or any affiliated entities thereof, officials, vehicle owners, drivers, builders and designers, crews, rescue personnel, any persons in any RESTRICTED AREA, promoters, sponsors, equipment and parts manufacturers and suppliers, advertisers, owners and lessees of premises used to conduct EVENT, premises and event inspectors, surveyors, underwriters/brokers, consultants and others who give recommendations, directions, or instructions or engage in risk evaluation or loss control activities regarding the premises or EVENT and for each of them, their directors, officers, agents, and employees (hereinafter collectively referred to as "RELEASEES"), FROM ALL LIABILITY TO PARTICIPANT, their personal representatives, assigns, heirs, and next of kin, FOR ANY AND ALL LOSS OR DAMAGE, AND ANY CLAIM OR DEMANDS THEREFORE ON ACCOUNT OF INJURY TO THE PERSON OR PROPERTY OR RESULTING IN DEATH OF PARTICIPANT ARISING OUT OF OR RELATED TO EVENT, WHETHER CAUSED BY NEGLIGENCE OF ANY RELEASEE(S) OROTHERWISE.
- 3. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the RELEASEES and each of them FROM ANY LOSS, LIABILITY, DAMAGE, FEES OR COSTS they may incur arising out of or related IN ANY MANNER TO PARTICIPANT'S ATTENDANCE AT OR PARTICIPATION IN EVENT, AND WHETHER CAUSED BY THE NEGLIGENCE OF ANY RELEASEE(S) OR OTHERWISE.
- 4. HEREBY ASSUMES FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE arising out of or related to EVENT, whether caused by the NEGLIGENCE OF ANY RELEASEE(S) OR OTHERWISE.
- 5. HEREBY acknowledges that THE ACTIVITIES OF EVENT ARE DANGEROUS and involve the risk of serious injury and/or death and/or property damage. PARTICIPANT also expressly acknowledges that INJURIES RECEIVED MAY BE COMPOUNDED OR INCREASED BY NEGLIGENT RESCUE OPERATIONS OR PROCEDURES OF THE RELEASEES.
- 6. HEREBY agrees that this Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement extends to all acts of negligence by the RELEASEES, INCLUDING NEGLIGENT RESCUE OPERATIONS and is intended to be as broad and inclusive as is permitted by the laws of the State of Nevada and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

THIS AGREEMENT SHALL BE INTERPRETED UNDER THE LAWS OF THE STATE OF NEVADA. If any part of this Agreement is adjudged to be invalid for any reason, *PARTICIPANT* agrees that the remaining terms of the Agreement remain in full force and effect.

PARTICIPANT HAS READ THIS RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT PARTICIPANT HAS GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND HAS SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE OR GUARANTEE BEING MADE TO PARTICIPANT AND SIGNATURE IS INTENDED TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.
